

Tampa bank helps Coral Springs company sale

Hyde Park Capital Advisors LLC has assisted the sale of Pulsar Technologies Inc. to AMETEK Inc.

Hyde Park served as Pulsar's exclusive investment bank in the transaction.

No terms of the deal were disclosed.

Pulsar, based in Coral Springs, is a designer and manufacturer of specialized communications equipment for the electric utility market. Pulsar joins AMETEK as part of its Electronic Instruments Group, which provides advanced monitoring, testing, calibrating and display instruments.

Paoli, Penn.-based AMETEK (NYSE: AME) had 2005 revenue of \$808 million and manufactures and markets electronic instruments and electric motors worldwide.
